### Exposure controls

#### Protection of hands:

In case of contact with spray dust protective gloves made of butyl should be used (min. 0.4 mm thick), e.g. KCL Camatril, article no. 898 or similar products.

Solvent resistant gloves

Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/the chemical mixture.

Protective gloves

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation. Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation.

#### Material of gloves

Fluorocarbon rubber (Viton)

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

#### Penetration time of glove material

Butyl rubber gloves with a thickness of 0.4 mm are resistant to:

Acetone: 480 min

Butyl acetate: 60 min

Ethyl acetate: 170 min

Xylene: 42 min

The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.

#### Eye protection: Tightly sealed goggles
